**ORDER PRESCRIBING NOTICE REQUIREMENTS**

Now on the 28<sup>th</sup> day of September, 2010, the Court being fully advised does Order, pursuant to Mo. Rev. Stat. § 375.1168.4, that Plaintiff provide notice of the Motion for Approval of Assumption Reinsurance Agreement and Reformation of Producer Agreements to National States Insurance Company ("National States") producers in the manner prescribed below.

A hearing on said Motion is scheduled for October 8, 2010 at 11:00 a.m. before this Court.

Plaintiff shall notify producers of the hearing time and place, and provide a link and/or listing of the website address for National States where the Motion for Approval of Assumption Reinsurance Agreement and Reformation of Producer Agreements, and Exhibits thereto, can be accessed by producers. Those producers who are not able to view the documents on the website may request that plaintiff email or fax copies of the documents to them. The provision of notice and the pleading in an electronic format will ensure that producers have notice and access to the information, and it will conserve assets of National States.


Notice shall be provided electronically when possible to conserve assets of National States, in the following manner:

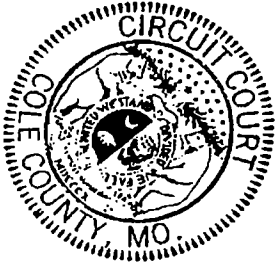

- To the last known email address of the producer;
- If National States has no email address for an producer, then to the last known fax number of the producer; or
- If National States has no email address or fax number for a producer, then to the last known mailing address of the producer.

The provision of notice in this manner will ensure that producers have adequate notice of the Motion for Approval for Assumption Agreement and Reformation of Producer Agreements, and an opportunity to appear at the hearing.
